

**ARTICLES OF INCORPORATION**  
**of**  
**NEVADA FBLA-PBL, INC.**

KNOWN ALL MEN BY THESE PRESENT:

That the NEVADA FBLA-PBL, Inc. is hereby incorporated pursuant to Nevada Revised Statutes Chapter 82 and that the following articles of incorporation are adopted for such nonprofit corporation.

**FIRST**: That the official name of the corporation shall be the NEVADA FUTURE BUSINESS LEADERS OF AMERICA – PHI BETA LAMBDA, INC. hereafter referred to as “Nevada FBLA-PBL, Inc.” Nevada FBLA-PBL, Inc. is chartered as a member of the national Future Business Leaders of America – Phi Beta Lambda, Inc. with the state charter held by Nevada Department of Education.

**SECOND**: The period of duration of the corporation is perpetual.

**THIRD**: That the purpose for which this corporation is formed are:

- A) The primary purpose of the Nevada FBLA-PBL, Inc. shall be to develop future leaders and improve educational and career opportunities for students interested in business and business-related careers, and to help students build self-esteem, experience leadership, and practice community service.
- B) The general purposes and powers are to have and exercise all rights and powers conferred on nonprofit corporations under the laws of

Nevada, including power to contract, rent, buy or sell personal or real property; provided, however, that the corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the primary purpose of this corporation.

**FOURTH**: The name and address of the initial resident agent of the corporation is Dr. Greg Richens, Nevada Department of Education, 1820 East Sahara Suite 205, Las Vegas, NV 89104-3746.

**FIFTH**: The initial number of trustees of this corporation shall not be less than one and shall be derived from a broad spectrum of education and business. The names and addresses of the persons who are presently serving as the initial trustees of this corporation are as follows:

Subsequent membership shall be based upon the Nevada FBLA-PBL, Inc. Board of Trustees Bylaws and the number of trustees shall be changed from time to time according to the Board of Trustees Bylaws.

**SIXTH**: Authority to regulate the affairs of this corporation shall be vested in the trustees. Position on the Board of Trustees shall be in accordance with the Board of Trustees Bylaws of this Corporation.

**SEVENTH**: This corporation is not organized, nor shall it be operated for pecuniary gain or profit, and it does not contemplate the distribution of

gains, profits, or dividends to the members thereof and is organized solely for nonprofit purposes. The property, assets, profits and net income of this corporation are irrevocably dedicated to charitable and educational purposes and no part of the profits or net income of this corporation shall ever inure to the benefit of any trustees, officer or member thereof or to the benefit of any private shareholder or individual. No substantial part of this corporation's activities shall consist in carrying on propaganda, or otherwise attempting to influence legislation. This corporation shall not participate or intervene in any political campaign on behalf of any candidate for public office. Upon the dissolution of this corporation, its assets remaining after repayment of, or provision for payment of, all debts and liabilities of the corporation, shall be distributed to a nonprofit fund, foundation or corporation, which is organized and operated exclusively for charitable and educational purposes and which has established its tax exempt status under Section 501(c)3 of the Internal Revenue Code. If this corporation holds any assets in trust, such assets shall be disposed of in such a manner as may be directed by decree of the Superior Court of the county in which this corporation's principal office is located, upon petition therefore by the Attorney General or by any persons concerned in the liquidation.
